Are you seeking support for Infant and Early Childhood Mental Health Consultation (IECMHC)? NM SEED Consultants in your area are currently open for referrals! IECMHC is a collaborative, relationship-focused approach designed to strengthen caregivers' abilities to promote and enhance children's social and emotional development. By working together, consultants and caregivers can help foster health emotional growth and resilience in young children. From the Endorsement Coordinator

As we move into the last quarter of the year, I want to provide a reminder that the Endorsement Renewal process will **not** take place this year.

- All current endorsements are active through December 31, 2027. Please continue to participate in a yearly target of 15 hours of training related to the IMH Competencies and for those endorsed at IFS, IMHS, IMHM-C and ERS a yearly target of 12 hours of qualifying Reflective Supervision/Consultation. For those that provide RSC to others, a yearly target of 3 hours of training related to the provision of RSC to others is required.
- Please see the table below if you are unsure of how many total hours you will need by the next renewal period.
- Endorsements are now active on a 3-year cycle. Everyone will renew by December 31, in the same renewal year (2027, 2030, 2033, etc.).
 - Anyone currently endorsed (and those who become endorsed before December 31, 2026) will be active through December 31, 2027
 - Anyone who becomes endorsed after January 1, 2027 will be active through December 31, 2030 (Renewal is not due the same year of initial endorsement)

Don't Forget: Endorsement Office Hours every Tuesday from 7:30am-8:30 am via Zoom.




AUBRY DAVIS
